### Business part of meeting/ taking a break: Sign up for Workshops

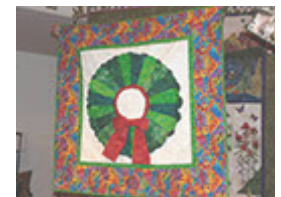

### **"Creativity Unleashed: Modern Technology for Quilters"**

Just what can you do with Modern Technology in quilt making? In this lecture, Jennifer shares her experiences and designs using Adobe Photoshop Elements and Electric Quilt along with inkjet printing on fabric. Features of both tools are shown during the presentation along with many samples of the quilts made using modern technology. The lecture is a Powerpoint presentation / trunk show format.



### **Workshop January 9 "Modern Tools Sampler"**

Using Photoshop Elements, you will learn how to transform and edit photos or fabric scans into a custom background or an art quilt, and how to prepare photos for printing. Topics include but are not limited to: scanning photos, copyright issues, fabric & printer choices, plus info on using print-on-demand services like Spoonflower.com. Practice samples will be provided.

You will also learn your way around Electric Quilt. Topics include, but are not limited to: How to use the sketchbook and libraries, Scan and import your own fabrics, Set blocks into quilt layouts, Add Borders, Color blocks, Print quilt and fabric yardage, Print block patterns, etc.

Workshop participants will need a laptop computer, power cord, mouse and mouse pad.

**NOTE:** It is **VERY** important that you install your free trial version of Photoshop Elements before class. Don't open it until class though, as you will only have 30 days on your free trial. Read the supply list (available on the web site) for more info.

Jennifer will install **EQ7** for you on your PC computer during class time. If you have a Mac with Windows installed, you may be able to run the free PC version on your laptop. Otherwise, you might have to share a PC with a partner. There is a Mac version of EQ7 but there is no trial version.

### **"Storm at Sea: From Traditional to Contemporary, an Ocean of Design Possibilities"**

Design explorations using the traditional "Storm at Sea" block, based on my book, "A New Light on Storm at Sea Quilts". Why do those straight seams give the feeling of curves? How can a 100-year-old block pattern work with current fabrics and color combinations for a fresh new look? You'll be amazed at how this versatile block can produce such a wide variety of unique quilt designs.



### **Workshop February 13 "Storm at Sea / TRIMplate Piecing"**



My TRIMplate rulers are not templates. They are unique tools that allow you to trim after you sew for greater accuracy. All fabric pieces start as squares or rectangles, so they are easily and quickly cut from strips. This method uses no templates, no paper or foundation piecing, and there is no bias on the outer edge of the blocks. Students choose one of 3 variations to make. (See samples above.) All patterns are supplied - students are not required to purchase TRIMplate tools, books or kits. ## A Note from Your Treasurer

The Guild's Board of Directors has received some inquiries recently about the state of the Guild finances, so I have been directed by the Board to present some information to the whole membership regarding the decline in our resources in the December and January newsletters, including Income and Expense Reports for the 2013-2014 fiscal year, and for the First Quarter of the 2014-2015 fiscal year. You will find the two Income and Expense Reports in the on-line newsletter. In addition, we will hold a meeting on January 8, 2015, from 5:30 to 6:30 pm, before the regular Guild meeting to discuss in more depth any questions members may have about our finances. Everyone is welcome to attend this meeting, which will be held in the back room off the kitchen.

I am stating the obvious, I think, to say that our financial resources depend on two factors—the amount of money we receive, and the amount of money we spend. The decline in our balance over the last 4 years has been due to a combination of these two factors—a decrease in our income, and an increase in our expenses. This month, I will briefly address in broad terms the decrease in our income. Next month, I will address the increase in expenses.

Since 2010, our income has declined in several ways. First of all, our total membership has declined from approximately 280 to approximately 230. This represents a decrease of approximately \$1500 in income even with the increases in membership dues. Besides a decline in revenues, a reduction in membership also affects the number of volunteers available to serve on various committees, make Community and Opportunity Quilts, and run the Harvest of Colors Quilt Show.

Membership dues, however, cannot be expected to cover all of our expenses and, particularly, to provide the programs, workshops, and other opportunities we want from our Guild. Even the State of California, in its guidelines for non-profit mutual benefit organizations like ours, expects that we will need to have fundraisers. However, we haven't had an Opportunity Quilt Drawing for the last two years, and our last auction was in 2011. In the past, Opportunity Quilt Drawings have raised between \$2200-\$3600 gross, so this has meant a significant loss in those years, requiring that we draw on our cash reserves to balance the budget. In the 2013-14 fiscal year, the only special fundraisers the Guild held were the Yard Sale at the Goleta Valley Community Center and the Library Book Sale, both in August, 2013. These raised \$1399 less expenses, compared to the usual auction held bi-annually which raised \$7161 less expenses in 2011-12. The Quilt Show gives us a net income of \$6,000 to \$8,000, but a large portion of that must remain available for deposits and other expenses for the next Quilt Show that happen before we receive any income from that show. At present, our cash reserves, in the form of two CD's, total \$13,002.

In next month's newsletter I will address our expenses. In the meantime, remember that I am always available to answer questions or provide you with copies of the reports I give to the Board each month. Also, remember you are always welcome to attend our board meetings on the third Thursday each month (except December) at 6:30 pm at Maravilla in the Valencia Room. This is your Guild, so we need your input and ideas and your support to guide our decision-making.

## Brainstorming Ideas for Raising \$5000 to Balance the Budget

Over the last year under Carol Fay's leadership, the Board has closely examined our budget and taken every opportunity to reduce costs. Yet we are \$5000 short of balancing our budget for the next year.

One of the reasons for the shortfall is truly surprising: According to a survey by Quilting in America Quilt Survey 2014, the number of quilters in the United States has declined by 23% in the last 4 years! Our own membership over the same period has declined as well, by 24%, so our membership decline tracks very closely to the national average. But with fewer members, not only is our income from dues reduced, but also we have fewer volunteers to help with the many activities that keep the Guild functioning. Last month, we "brainstormed" ideas for raising the money to balance our budget without reducing our guest speaker programs, offering any idea that might help, without response, comment or discussion about its feasibility. Brainstorming enhances the creative problem-solving process and offers a wealth of possibilities. Perhaps your creative process has been stimulated to produce more ideas – if so, let's hear them! In fact, you will notice that a few ideas have been added since the last Board meeting.

Most of the ideas generated involve fund-raising events. Others require policy changes at the Board level, while still others are more easily accomplished. Efforts that target the public have a larger fund-raising potential than those that mainly target our own membership, but no idea for a source of added income will be turned away. One excellent idea is to make a thermometer to track progress toward our goal.

Among the ideas generated last month, the most easily implemented are the following: Pass the hat at membership meetings; have tip bowls in the refreshment and membership areas, and sell unwanted items on Craig's List, donating the proceeds to the Guild.

Some of the other ideas require volunteers along with some research and organization. These include: display our Opportunity Quilts at more events, try to increase our membership, perhaps by encouraging more men to become quilters and join the guild (a special beginners' class for men? A men's satellite group?), and create a cookbook and/or a book of quilting tips to sell. Ways of generating funds that require action by the Board include: raising dues, raising workshop fees at least enough to cover their costs, and inviting the local Modern Quilt Guild to participate in a joint membership program, which would bring new members to both organizations.

Events require the most volunteers, planning and organization, and the investment of funds and time. They also have the potential to bring in the most money toward our goal. They range from tried-and-true to new ideas for raising our visibility in Santa Barbara. Some of these ideas not only tap into funding streams from the public, but also potentially increase our membership by reaching out to quilters who are not members and by creating interest in quilting – let that quilting bug bite! Let's reverse that national trend here in Santa Barbara!

These ideas are, in a general way, organized according to their complexity:

## Community Quilts

During November, the Community Quilts Committee delivered 35 quilts, 25 Christmas stockings, and 185 doll cradle quilts including the mattresses, pillows and pillowcases that matched the quilts. Nineteen quilts went to Visiting Nurse & Hospice Care, which is the hospice program that provides medical support. Of these quilts, three were red, white and blue, and we learned that VNHC has a special program for veterans in which a quilt is presented during a "pinning" ceremony. In less than 10 days, all three of these quilts had been presented to veterans. If you were at the November meeting, you heard a bit about that; in January, there will be an article about the larger Visiting Nurse and Hospice Care agency. Ten quilts went to Hospice of Santa Barbara. This is the non-medical model of hospice which provides emotional support not only for the client but also for their family and for any member of the public who is grieving the loss of a loved one. They serve all ages, from very young children to the elderly. In February, the newsletter will carry an in-depth article about their agency devoted to helping with the grieving process.

Nine children's quilts went to CALM, including a quilt that we selected especially for a 6-month-old baby in the Pediatric ICU at Cottage. That quilt was delivered to the baby's family the following day. Later on in 2015, there will be another article in the newsletter detailing the work of this agency and the part our quilts play in that work.

Each of these agencies serves thousands of clients per year; we deliver so few quilts in comparison to this vast need. However, each client has an agency social worker who gets to know each client very well. When quilts are delivered, the social workers make the choices, matching quilts – color, theme, and size – to the clients who need them most. Cries of "Ooooh! This quilt would be perfect for ... (client)!" are common following our deliveries. Thus the quilts are distributed very quickly to where they will do the most good.

In addition to our quilt deliveries, Transition House had requested 25 Christmas stockings before Thanksgiving, and we met that deadline handily – thanks mostly to Marian Jones sewing non-stop for more than two weeks.

And we delivered 185 cradle quilts with bedding to Steve Scheftic, who teaches woodworking at the Wake Center and is the "CEO" of the retired GM/Delco engineers who make the cradles and thousands of other toys as well. All of these toys, including the doll cradles with our doll quilts and bedding, go to Unity Shoppe, where, I'm told, little girls spend long periods of time studying the cradles and quilts before making their selection. The retirees who make these toys and Unity Shoppe will be the subject of yet another article in 2015.

By the end of our Guild-year in June, we should all be much better educated about what happens to the quilts made by our members and donated to the Community Quilts. We offer a huge "Thank You" to everyone who contributed the quilts which are making such a difference in these clients' and veterans' lives.

# ON THE FENCE

January 2015 | Block of the Month  
Coastal Quilters Guild

This block is a twist on a traditional Rail Fence.  
Rotate every other block 90 degrees for a striking  
setting (Based on a design by Weeks Ringle and Bill Kerr)

## FABRICS & CUTTING

Kona white - provided  
A single solid color of your choice

### White fabric:

Cut 6 strips 3/4" x 13"

### Solid color fabric:

Cut 2 strips 3-1/4" x 13"

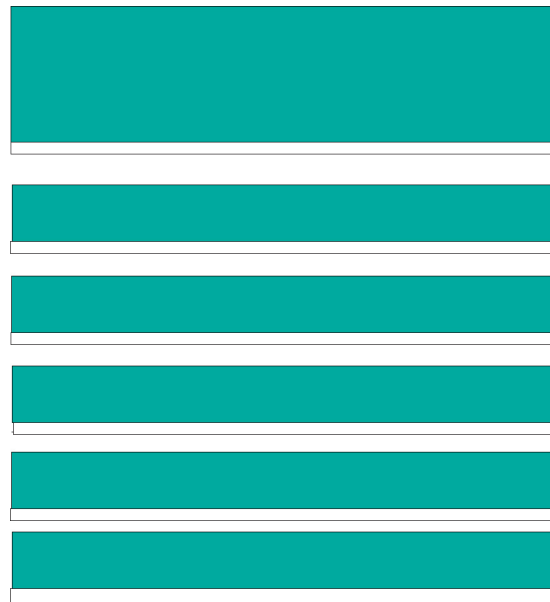
Cut 5 strips 1-1/2" x 13"



## CONSTRUCTION

Use 1/4" seam allowances.

1. With right sides together, sew a 3/4" x 13" white strip to the bottom of each 1-1/2" x 13" solid color strip.
2. Sew the remaining 3/4" x 13" white strip to the bottom of a 3-1/4" x 13" solid color strip.
3. Press all the seams **open**.
4. Lay the strips out as shown in the diagram.
5. With right sides together, sew the units together.
6. Add the remaining 3-1/4" x 13" solid color strip to the bottom of the block.
7. Press the seams open.
8. Trim the block to 12-1/2" x 12-1/2", *trimming equally from the top and bottom.*
